- **School Start Date**
House Bills 3477, 3256, 3095*

We firmly believe that school start dates should be a local decision. Starting dates affect the school calendar and thus the academic achievement of our students. By eliminating the uniform start date our county can start school earlier. During the past four years our fall semester has been interrupted by mandatory evacuation days due to hurricanes, resulting in a shortened fall calendar. Due to our late start some of our make up days are carried over into the Spring calendar.

- **Teacher Salaries**
Teachers are professionals and need to be compensated as such. The State of South Carolina needs to demonstrate that we value our teachers by raising their pay at minimum to the national average.

- **Fully Fund State Mandates**

We believe that the State should provide full funding for all educational programs that it so mandates. In addition, we believe that the SC Constitution should be amended to prohibit state mandates on local units of government unless they are fully funded by the state.


- **SRO and Mental Health Initiatives**

School safety is a top priority of all stakeholders, the Governor has called for an SRO in every school. They must be funded. By placing School Resource Officers in all schools, we send our students and staff the message that we value them. Funding for mental health initiatives must also be increased. Mental health support is paramount to identifying root causes of school violence and increasing safety in schools.

- **Education Funding Reform**

While there are many aspects to funding reform we believe that there are two extremely components necessary to reform. South Carolina must generate revenue that is adequate, stable and recurring and ensure that districts are held harmless from receiving less money through a new funding plan.
